The Company continued to witness good collection efficiencies during the quarter ended September 30, 2024, as can be seen from the collection efficiency data given above.

**Moreover, given current conditions, the Company has chosen to provide this update for the quarter ended September 30, 2024. The Company does not intend to provide similar updates for the coming quarters unless deemed necessary.**
